Why were castle built?

Kings, Queens or powerful people built castles to protect themselves, to live in, to control people, to win battles and to look important and wealthy.

Who first built castles in Britain?

In 1066, William the Conqueror defeated King Harold II at the Battle of Hastings and began the time of castle building in England that lasted until 1250.

What were the jobs in a castle in Britain in the past?

People who lived and worked in castles had many different jobs. These included soldiers, knights, servants, cook, jester, crafts people and the unfortunate gong-farmer.

Where were castles built?

Castles were built all across Britain and in many other parts of the world, such as Zimbabwe and Syria. Castles were often built on top of hills for protection and near rivers or the sea to help with vital supplies.

The Tower of London

The Tower of London began to be built in 1078 on the River Thames, by William the Conqueror.

People still live in the Tower of London today!

There is a governor, yeoman warders, soldiers, a doctor and a chaplain.

It is also a museum with 3 million visitors a year.

power	×	Influence behaviour of others




A motte and bailey castle in Britain

Great Zimbabwe in the continent of Africa


This was a medieval city in the south-eastern hills of modern day Zimbabwe in the continent of Africa.
